

EDMOND BEDROSSIAN received the DDS degree from the University of the Pacific, and completed his Oral and Maxillofacial Residency at Alameda Medical Center. Dr. Bedrossian is a Diplomate of the American Board of Oral and Maxillofacial Surgery. He is also A Honorary Member of the American College of Prosthodontists. He is a Professor , Department of Oral & maxillofacial Surgery, at the University of the Pacific School of Dentistry combining private practices with academics. He has authored multiple articles and chapters on the various uses of the Zygomatic implant, bone grafting and treatment planning implant dentistry. He has also authored the textbook "Implant treatment planning for the edentulous patient", Foreword by Professor Brånemark as well as his new book, "The Immediacy concept" Foreword by Professor Daniel Buser will be available from Quintessence in 2021. He has lectured with Professor Brånemark on the rehabilitation of patients with maxillofacial defects and collaborated with him in attaining FDA approval for the use of Endosseous implants in maxillofacial defects.

DR. SONIA LEZIY, periodontist, maintains a full time practice on Vancouver Island, British Columbia, Canada. She is a clinical associate professor at the University of British Columbia. She was awarded the Lucy Hobbs Award for mentorship in 2013, the Saul Schluger Award for excellence in teaching and education in 2014; the recipient of the 2022 Greater NY Academy of Prosthodontics Distinguished Lecturer Award, and she is recognized by Dentistry Today as a leader in continuing education. She is a member of numerous editorial boards, and is published in the areas of implant esthetics, editor of the implant section of Inside Dentistry/Aegis Publications. She is a fellow of the ITI and a member of the ITI Board of studies. She lectures internationally, and provides education programs through Elatus Dental Bio-Architecture (www.elatus.ca) and Vancouver Island Dental Specialists (www.videntalspecialists.com).



DR. PANOS PAPASPYRIDAKOS is a specialist Prosthodontist and his clinical expertise covers all aspects of Implant, Esthetic and Reconstructive Dentistry. He received both his Certificate of Specialty in Prosthodontics and M.S. degree with honorary distinction from Columbia University College of Dental Medicine. Subsequently, he received his Certificate of Fellowship in Implant Dentistry from Harvard School of Dental Medicine. He also holds a D.D.S. degree from the University of Detroit Mercy School of Dentistry and a Ph.D. degree from the National University of Athens School of Dentistry. Dr. Papaspyridakos serves as an Associate Professor of Postgraduate Prosthodontics at Tufts University School of Dental Medicine and as adjunct Associate Professor of Prosthodontics at the University of Rochester Eastman Institute for Oral Health, and he maintains a private practice limited to Prosthodontics and Implant Dentistry in Boston MA. Dr. Papaspyridakos has published more than 100 articles and abstracts in international peer-reviewed journals and has authored book chapters in 10 Implant Dentistry textbooks, while he serves as reviewer for several dental journals. His innovative clinical implant research is widely cited and has received international acclaim with educational awards. He is a fellow of the International Team of Implantology (ITI) and the Greater New York Academy of Prosthodontics (GNYAP) and he lectures extensively on dental implants and esthetics in national and international dental meetings.



DR. EFFIE HABSHA earned her DDS, Diploma in Prosthodontics and Master of Science degrees from the University of Toronto. She is an Adjunct Assistant Professor at the Department of Dentistry, Eastman Institute for Oral Health at the University of Rochester Medical Center. Dr. Habsha has served as an Assistant Professor at the University of Toronto and currently instructs both at the undergraduate and graduate level in Prosthodontics at U of T. She is also the founder of Women in Dentistry: Work.Life.Balance, a group created in 2010 for women in dentistry which aims to educate, empower and connect all women in the dental field. Dr. Habsha maintains a private practice limited to Prosthodontics in Toronto and lectures nationally and internationally on various prosthodontic and surgical topics.
